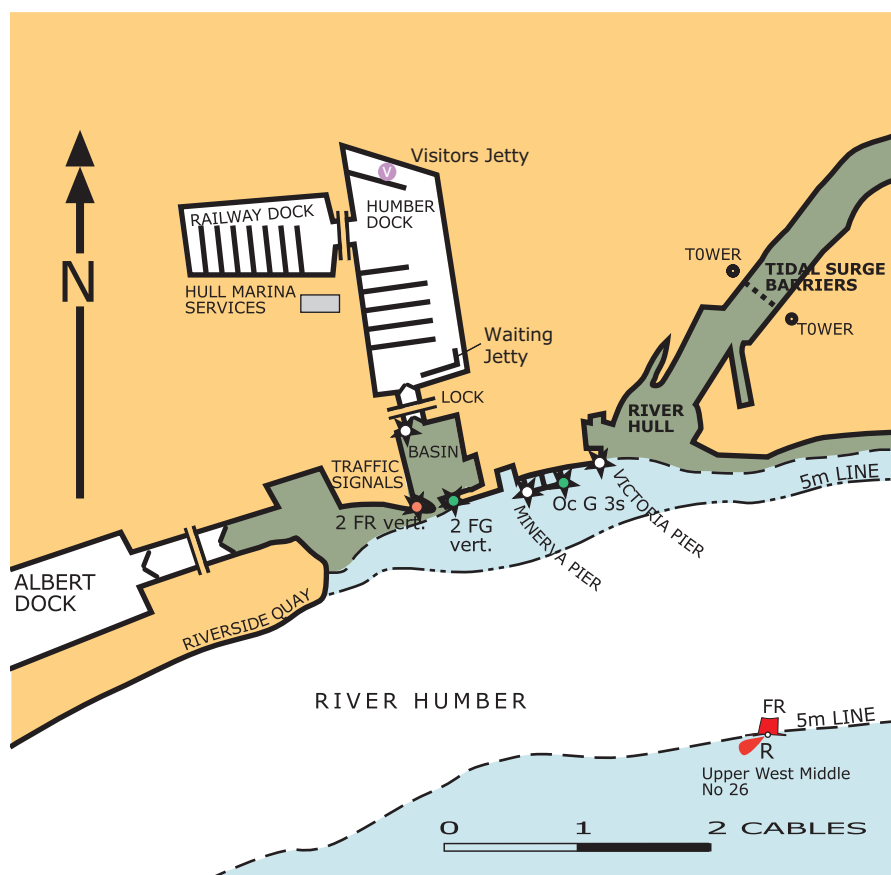

Col 2, Lights and visitor berths added
Amend text:

Entrance

Enter on a bearing of 225° At night, the harbour entrance is marked with Port and Starboard lights. West Arm: Grn Fl. 4secs. East Arm: Red Fl. 4secs

Mooring

Local fishing boats can take up all available space, particularly when conditions are poor and the only shelter is up the river.

Shallow draught boats may be able to lie afloat, particularly at neap tides against the north breakwater where there are ladders.

There are a limited number of visitor berths on the South Breakwater with additional mooring rings and ladders added 2018

RIVER TYNE ENTRANCE

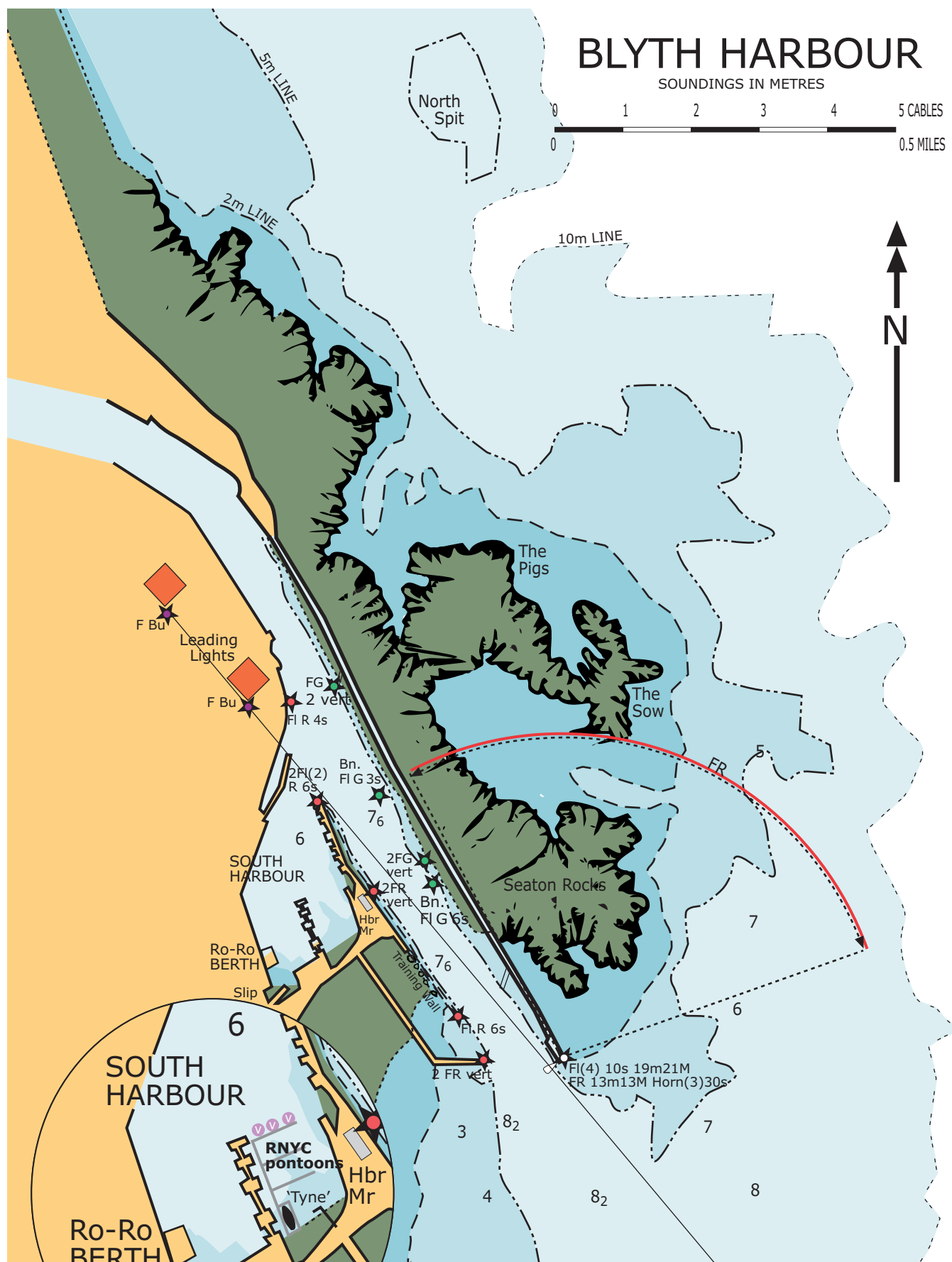

p 34 Blyth Harbour

The 2 turbines at North Spit have been decommissioned (2019)

Col 1 Para 1 delete: “and two more in the bay to the north”

p 38 River Wansbeck

Col 1 para 4, col 2

The lock is no longer in use due to silting in the lake.

Delete “ There is a lock which will take boats up to the following size:-

Length: 9.1m Beam: 2.4m

Draught: 1.6m Headroom: 2.6m.

Although the gates are opened occasionally in winter to flush out silt, there has been no demand for the passage of small craft. The lock is controlled by Wansbeck Council Leisure Dept. Tel: 01670 844200.”

Add “Lock no longer in use”

p 80 Dunbar

Col 1 para 5 - Approach

Changes to leading marks:

Delete “The leading marks, which stand on a grassy bank, are two orange concrete posts with white topmarks, showing occulting green at night.”

Replace with “The leading marks are orange triangles on posts on a grassy slope. At night they show green lights Oc G 6 s 15m 3 m on the lower and Oc G 6s 22m 3 M on the upper mark which is at street level.

Col 2, paras 2 & 3 - changes to mooring arrangements from Dunbar Harbour Trust

Entrance - add at end of text “It is best to keep close to the north wall at the entrance, making a starboard turn immediately inside the harbour where visitors’ berths are located.”

p 80/81 Mooring - Delete whole section and add:

“There are two harbours in Dunbar. The visitors berth is just inside the harbour entrance, below the Harbour Master’s Office. Depths on the south quay of Victoria Harbour vary from 0.5 to 1.5 metres, the bottom is sandy. The Victoria Harbour is liable to scend and is uncomfortable or dangerous in strong winds from north-west to north-east. Even in quieter weather a range can work in. If this happens perfect shelter can be obtained in the Old or Cromwell Harbour, through the lifting bridge, where the bottom is largely soft sandy mud. The Low Quay in the south-east corner covers at high water springs. The Harbour Master controls the bridge opening.

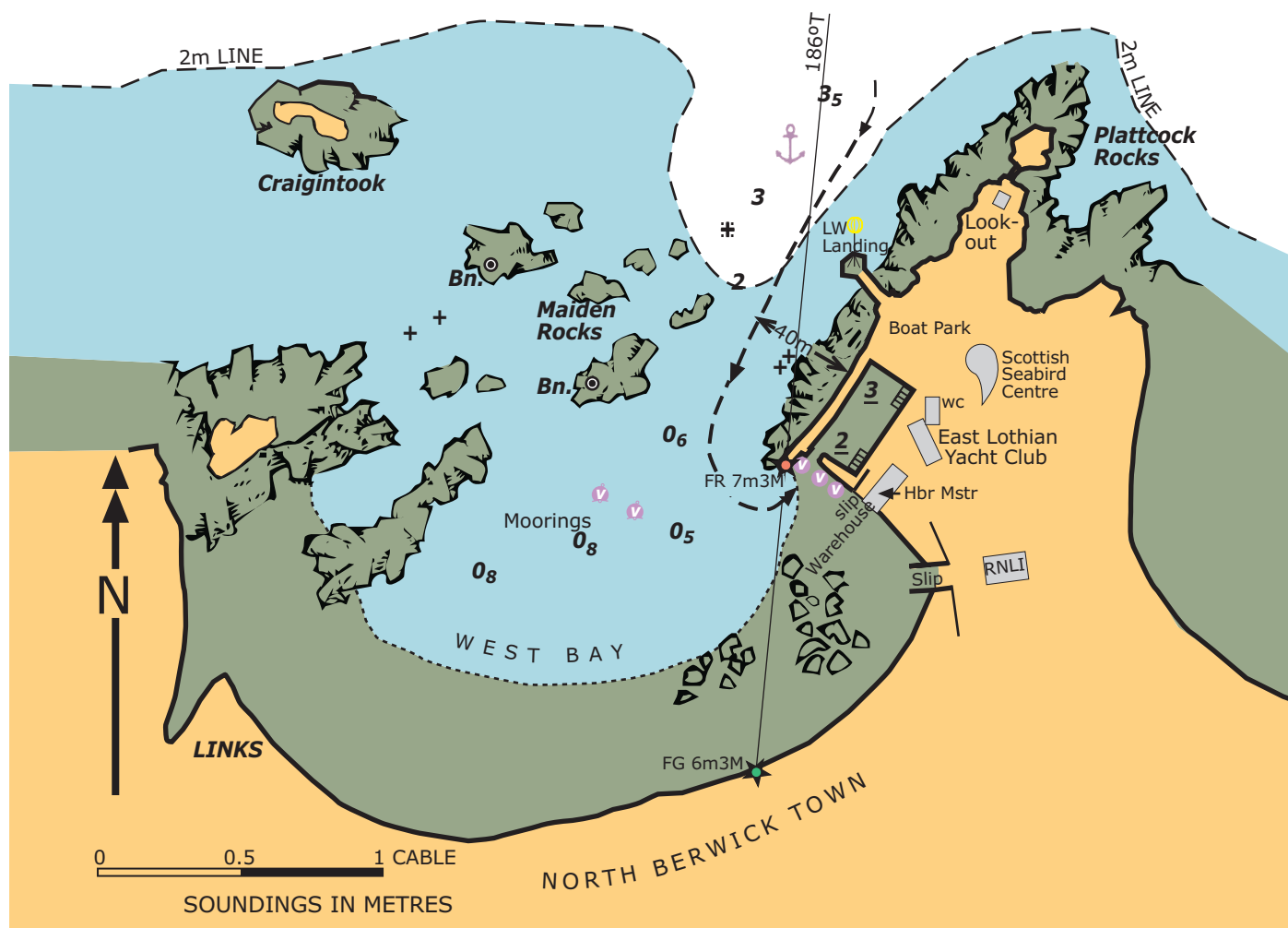

After “there are two E.L.Y.C. visitor moorings here in season” **Add** , “they are best used as overtime moorings. Overnight stays can be uncomfortable due to swell

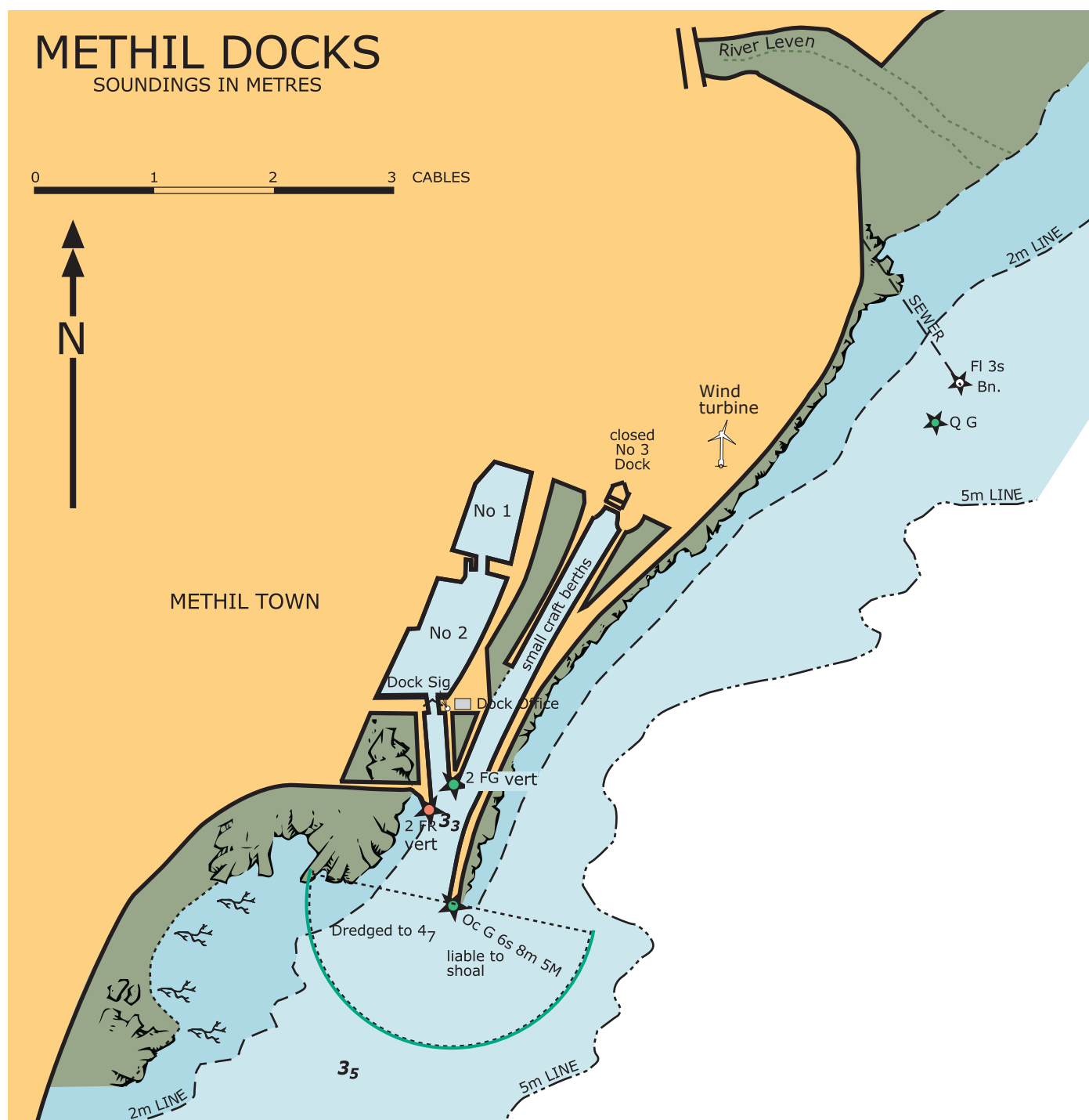
para 2 Approach

Replace para with: “Large wind turbine on the dock foreshore is a good landmark. The entrance has a straightforward approach from either the south or the east.”

Delete Power Station and chimney. Add turbine on foreshore at north end of docks

Entrance - add: Access HW +/- 4 hours

General

Add: Dundee Waterfront is home to V&A Design Museum and HMS Discovery. There is a museum dedicated to the jute trade in the town.

Dundee Docks

The lock gates are inoperable.

Delete from: “Yachts may lock into Dundee docks...” to “ ... development plans”

Replace with: “There are plans for future development of a city marina in Camperdown Docks, where Unicorn and North Carr Lightship are currently docked.”

p112 Tayport

Tayport Harbour Trust have provided up-to-date information. pdf of revised p112 on following page.

Tayport

Tayport has a small tidal harbour which offers good shelter and facilities for yachts. The depth varies with dredging and the shoal sand in the river can be more of a problem than the mud inside. (See chart on page 110)

Approach

Tayport harbour entrance is marked by a fairway buoy at the edge of deep water approximately 100 m from the harbour wall. The harbour is accessible approx. 4hrs either side of high water depending on draught.

Entrance

The entrance is at chart datum and the harbour starts to dry at about 0.4m below chart datum (in 2017) into soft mud which all keels settle into with no problems. Once through the entrance keep to the east quay for the best water.

Leading marks are given by two dayglo yellow triangles - one on the slipway wall and one set back on a pole, on a bearing of 185 degrees true. The entrance walls are painted white on either side to make them easier to see.

The East wall, the roundhead, is marked with a red and white striped pole which is lit by a red flashing light at night Fl R 5s. The West and inner wall is marked with a green and white pole which is lit by a green flashing light at night Fl G 5s.

Mooring

Visitors are strongly advised to book ahead. (There is no harbour master at Tayport). When possible, temporary berths will be provided on the pontoons but where this is not possible, visitors may have to take a wall berth or raft up.

Facilities

The harbour is a charity run by volunteers and whilst everything that can be done to facilitate your visit and make it more comfortable, Tayport is not a marina and its facilities are correspondingly limited. A Toilet and Shower block is located on the site and visitors are given the access codes for this. Water and electricity is available.

The shops and facilities of Tayport are available within 200m or so. These include a good supermarket, chemist, ironmongers, post office and cash machine. cafe (The Harbour Cafe) which serves lunches and snacks. The Bell Rock Tavern sells real ale and good pub food. Other public houses and take-aways are within easy walking. Buses to Dundee and St. Andrews.

General

A perfectly sheltered, quiet and pleasant harbour, despite its lack of water. Tayside is a much better option in strong westerly weather than the moorings of the R.T.Y.C. at Broughty Ferry. The harbour was built by the North British Railway to provide the ferry link across the river prior to the opening of the ill-fated Tay Bridge in 1878.

River Tay to Perth

The river is navigable as far as Perth and frequently used by commercial vessels drawing up to 12 feet. Navigation is quite straightforward and buoyed. There is a full description in the now out of print (2011) FYCA "Pilot Handbook" It is a scenic and interesting trip. Yachts are advised to contact Harbour Master before entering the harbour limits. 01738 624056, VHF Ch. 19

After “Keep at least a mile offshore, but much more if a large swell” Add: “Keep clear of the 11 turbine windfarm 4 miles N of Aberdeen, offshore of the Black Dogs firing range”

Approach

Add: “There are many marked lobster pots on either side of the leading line”

Mooring

Delete:

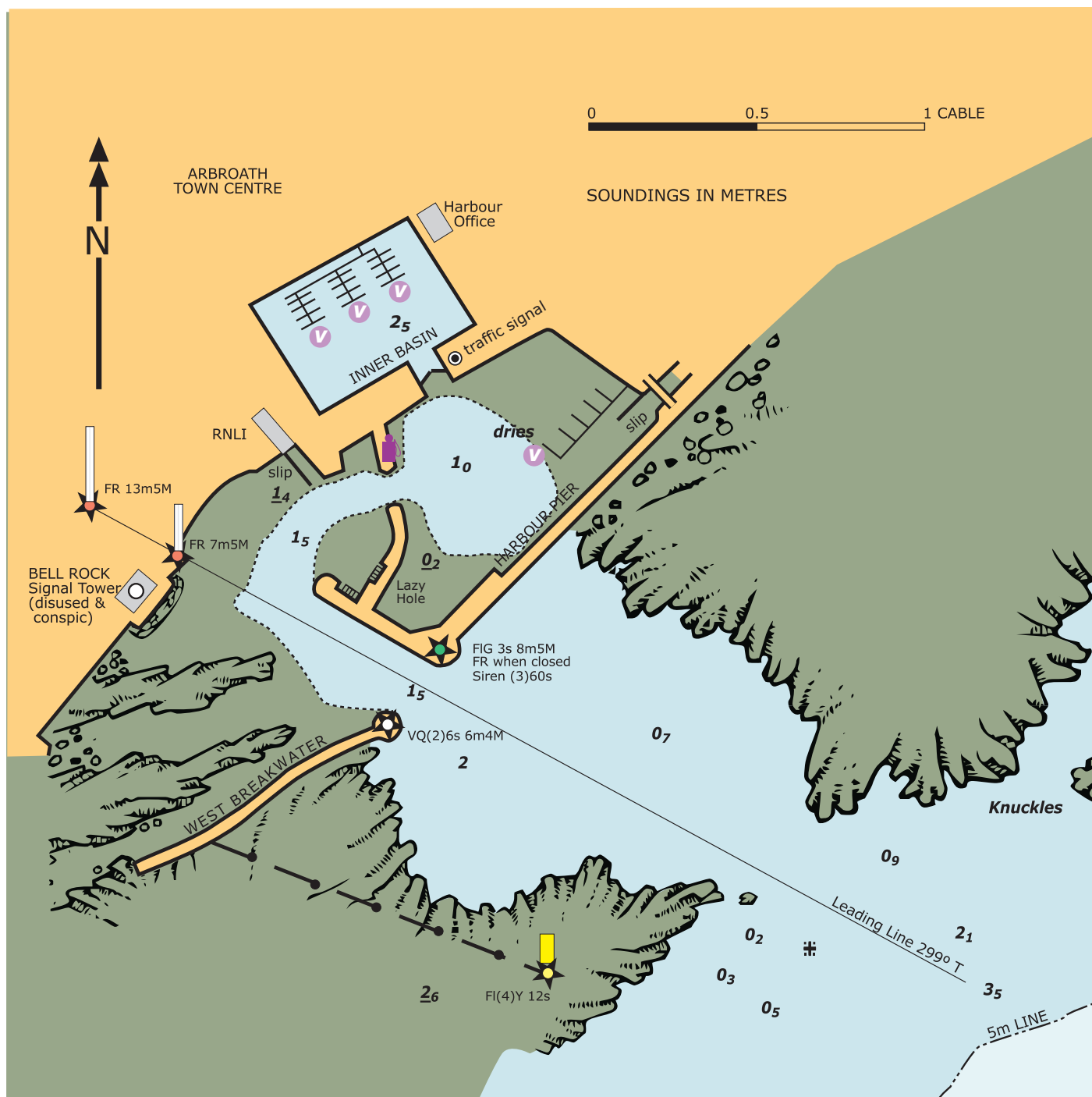
“This once-busy harbour is now quiet and there is plenty of room. Vessels can take the ground at the visitor berth in the Lazy Hole or take one of the visitors’ berths on the pontoons. The gates are opened during the top half of the tide during the working hours of 0700 to 2000 hrs.”

and replace with:

“There are six visiting pontoon berths in the inner harbour where a depth of water 2m is maintained by the use of dock gates at the entrance which open & close at half tide. A single pontoon in the outer harbour is available for those yachts which enter the harbour when the dock gates into the inner harbour are closed, added in 2019”

Facilities

There is water and electricity on the pontoons. Showers, toilets and launderette on the harbour wall.
