Notes for Membership Applicants

- 1) Royal Northumberland Yacht Club Limited is a company limited by guarantee (company number 08544867) and carries on its business under the name Royal Northumberland Yacht Club
- 2) The objects of the Royal Northumberland Yacht Club shall be to promote community participation in the sport of sailing by the provision of facilities and instruction and to encourage the building and improvement of yachts
- 3) Amateurs only are eligible
- 4) Membership Types are as follows:-

a) Ordinary	Persons aged 25 or over
b) Ordinary (Reduced)	Persons who have attained 18 but not yet 25 years of age (18 - 24)
c) Ordinary (Family)	Husband and Wife, or Partners living at the same address with or without children (being cadets). Single Parent with children (being cadets)
d) Cadet	Persons who have attained 7 but not yet 18 years of age (7 - 17)
e) Associate	Persons who make less than normal use of the Club's facilities
f) Student	Available to persons in full time education and has not yet attained 25 years of age (proof of this will be required each year)
g) Country	Persons residing outside of Northumberland, Tyne & Wear or Co. Durham and have been Ordinary members for at least 1 year
- 5) Subscriptions and Entrance Fees
 - a) Current subscriptions are shown in the Club year book and on the Club website at www.myc.org.uk
 - b) First year subscriptions are payable immediately on election
 - c) Subsequent subscriptions are due in advance on 1st February
 - d) An Entrance Fee of £50 is payable for all new members except Cadet members (not included in a Family membership) and temporary members.
 - e) The Club is fully affiliated to the Royal Yachting Association (RYA), however Club membership does not include personal membership of the RYA
- 6) Admission to membership does not guarantee mooring or boatyard accommodation
- 7) Mooring instructions must be understood and strictly adhered to in order to avoid unnecessary damage to craft
- 8) Members wishing to obtain sailing experience should contact the Honorary Sailing Secretary

Application process

When membership applications are received by the Honorary Membership Secretary they will be shown to the next General Committee of the club and also advertised on the club notice board. Applicants will then be invited to meet one or more of the Flag Officers of the club.

Once the application proceeds, an invitation to join the club will be posted out together with a request for the relevant subscription and joining fee. Please do not send money with the membership application form.
